The proposed 2025 budget increased by \$411,710. The increase is due to an increase in capital expenditures via the reserve for future capital outlays in the amount of \$410,000.00. Also there was an increase in the amount of debt service of \$ 625. In addition, there were increases in interest income of \$284,196, unrestricted fund balance of \$50,000, salary and wages of \$12,802, commissioners of \$2,825, office supplies of \$5,000, payroll tax of \$105, professional services of \$350, uniforms of \$10,000, contracted services of \$2,805. promotion of \$1,000, and maintenance of \$5,000.

The SCBA Tanks are needed to replace old tanks that are 15+ years old. The new vehicle is to replace Dodge Durango that was totaled in an accident in 2023. These two items increased the budgeted capital appropriations by \$410,000 or 246%. Interest income increasing significantly due to better market conditions and more funds transferred to CD's. Uniforms and personnel equipment need to be replaced. Contract Services is also increased for the protection of the residents. Health and fitness are increasing for more training. Office supplies are increasing for more activity at firehouse. Promotion is increasing to attract new volunteer members. Increase to Fund Balances to offset the increase in appropriations to keep the district within the cap levy. Admin and salary wages increased due to scheduled increases to all non-commissioners such as Treasurer, IT, etc.. Debt service interest increasing due to the loan coming to an end and more principal being paid than interest.

Unrestricted fund balance and restricted fund balances are being utilized appropriately for capital purchases
