

**RESOLUTION OF THE BOARD OF FIRE COMMISSIONERS OF  
FIRE DISTRICT NO.2 MANALAPAN TOWNSHIP SCHEDULING A  
SPECIAL MEETING FOR DECEMBER 16, 2013**

**WHEREAS;** The Board of Fire Commissioners has determined that it is necessary and in the public interest for the Board to undertake certain capital improvements in budget year 2014 including upgrading radio equipment, the installation of additional opticom traffic preemption units and the construction of a new utility building at the Sweetmans Lane firehouse; and

**WHEREAS;** The estimated combined costs of these capital projects is approximately \$595,000.00 allocated as follows: radio upgrade ( \$45,000.00), opticom traffic preemption system (\$125,000.00), construction of new utility building (\$425,000.00); and

**WHEREAS;** N.J.S.A. 40A:14-84 permits fire districts to seek voter approval of proposed capital projects such as the acquisition of equipment used in connection with fire suppression activities by way of a " special meeting" called for such purposes; and

**WHEREAS;** Said statute provides that if the capital projects proposed to the voters at a " special meeting " are approved, the revenues so approved shall be included in the next succeeding annual budget of the fire district in the section of the budget reserved for capital appropriations; and

**NOW, THEREFORE, BE IT HEREBY RESOLVED** by the Board of Fire Commissioners of Fire District No.2 Manalapan Township that a " special meeting " be and the same is hereby scheduled for December 16, 2013 commencing at 4:30 p.m. at the Manalapan Township Volunteer Fire Company No.1 Firehouse, Sweetmans Lane Manalapan Twp. for the purpose of requesting voter approval of the above specified capital project at a total cost not to exceed \$595,000.00.

**BE IT FURTHER RESOLVED** that notice of this special meeting be posted in five public places within the Fire District as required by N.J.S.A.40A:14-85.

1. Our client does not intend to install a Sanitary Sewer Line unless and until it secures development approvals for its property. Accordingly, the installation of the sewer line and the connection of the fire house to same would be conditioned upon our client receiving development approvals and the right to install the Sanitary Sewer Line within the easement area.

## Month End Review

**Windows XP will be discontinued as of April 8, 2014.** It's advisable that all systems utilizing Windows XP be surplused and replaced before then as newer manufacturer software may not be compatible and there will no longer be patching or updates by Microsoft.

Laptops in Chiefs Vehicles, apparatus & Board equipment should be considered. In addition, several of the Board's laptops are out of warranty and over 3 years old. Best practices on workstations & laptops are to replace every 3-5 years. Servers are to be replaced every 5-7 years.

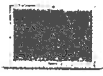
Earlier in 2013, both the on-site Network Attached Storage (NAS) drive and the unmanaged switch it was attached to experienced a failure. The Board has since moved critical documents to the cloud, however, there is no device currently backing up or imaging current network nodes. It is recommended that the Board purchase the Western Digital Sentinel DX4000 8Tb Storage Server and a Netgear ProSafe Plus 16-Port Gigabit PoE Unmanaged Switch. Quotes are attached for both items.

There have been previous discussions with fire company officers on the accountability system in place. The officers are looking for a solid-colored card to be used for identification at a distance and the current card system we have will not handle the printing of solid-colors. Accountability tags requiring to be solid-colored are recommended to be best handled by the officers.

The Training Officer is requesting the former laptop that was in 26-2-90 for training purposes. It is an older laptop running the Windows XP operating system.
