RESOLUTION AUTHORIZING DISPOSAL OF SURPLUS PROPERTY AT AUCTION

WHEREAS, Manalapan Township Fire District No. 2, Township of Manalapan, County of Monmouth, State of New Jersey, is the owner of certain surplus property which is no longer needed for public use; and

WHEREAS, the Commissioners of Manalapan Township Fire District No.2 are desirous of selling said surplus property in an "as is" condition without express or implied warranties.

WHEREAS, Manalapan Township Fire District No. 2 intends to utilize the online auction services of GovDeals located at www.govdeals.com; and

WHEREAS, the sales are being conducted pursuant to N.J.S.A. 40A:11-36 and the guidance set forth in the Division of Local Government Services' Local Finance Notice 2019-15.

NOW, THEREFORE, BE IT RESOLVED by the Board of Fire Commissioners of Fire District No. 2, Township of Manalapan, County of Monmouth, State of New Jersey, as follows:

(1) The sale of the surplus property shall be conducted through GovDeals pursuant to Sourcewell contract No. _____ (*insert contract number*) in accordance with the terms and conditions of the contract. The terms and conditions of the agreement entered into with GovDeals is available online at www.govdeals.com from 04-27-26 (*insert start date*) through 04-30-26 (*insert end date*) and also available from the Clerk of Manalapan Township Fire District No. 2.

(2) The sale will be conducted online and the address of the auction site is www.govdeals.com.

(3) The sale is being conducted pursuant to Local Finance Notice 2019-15.

(4) A list of the surplus property to be sold is attached as Exhibit A.

(5) The surplus property as identified shall be sold in an "as-is" condition without express or implied warranties with the successful bidder required to execute an Indemnity, Defense and Hold Harmless concerning said surplus property.

(6) The Manalapan Township Fire District No. 2 reserves the right to accept or reject any bid submitted.

BE IT FURTHER RESOLVED, that a signed, conformed and compared copy of this Resolution be maintained by the Board of Fire Commissioners of Fire District No. 2 as an official Board record pursuant to and in accordance with the "Open Public Records Act", N.J.S.A. 47:1A-1 et seq. and pursuant to and in accordance with the State of New Jersey Municipal Agencies Record Retention Schedule promulgated by the Division of Archives and Record Management.
